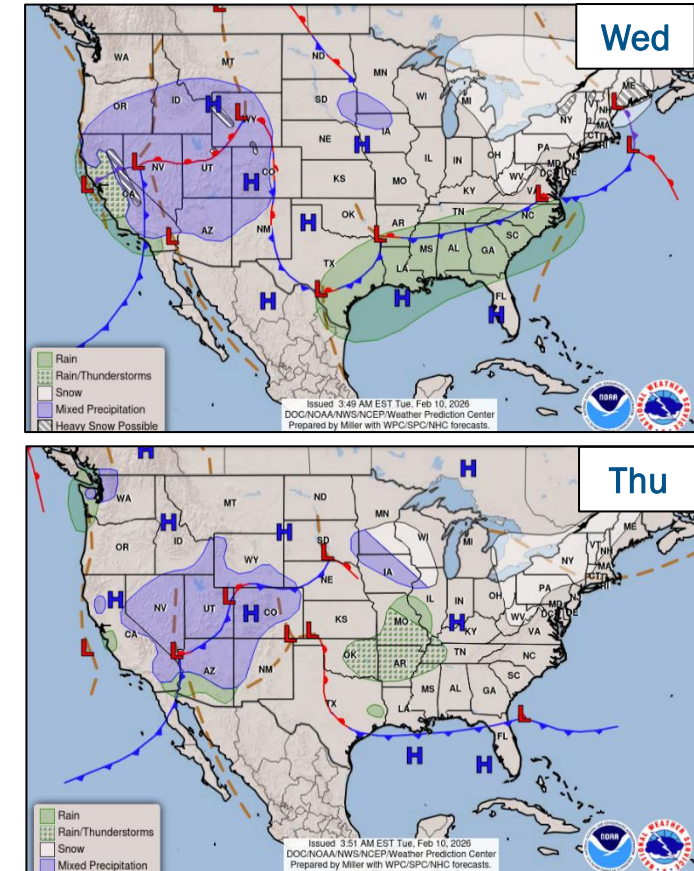
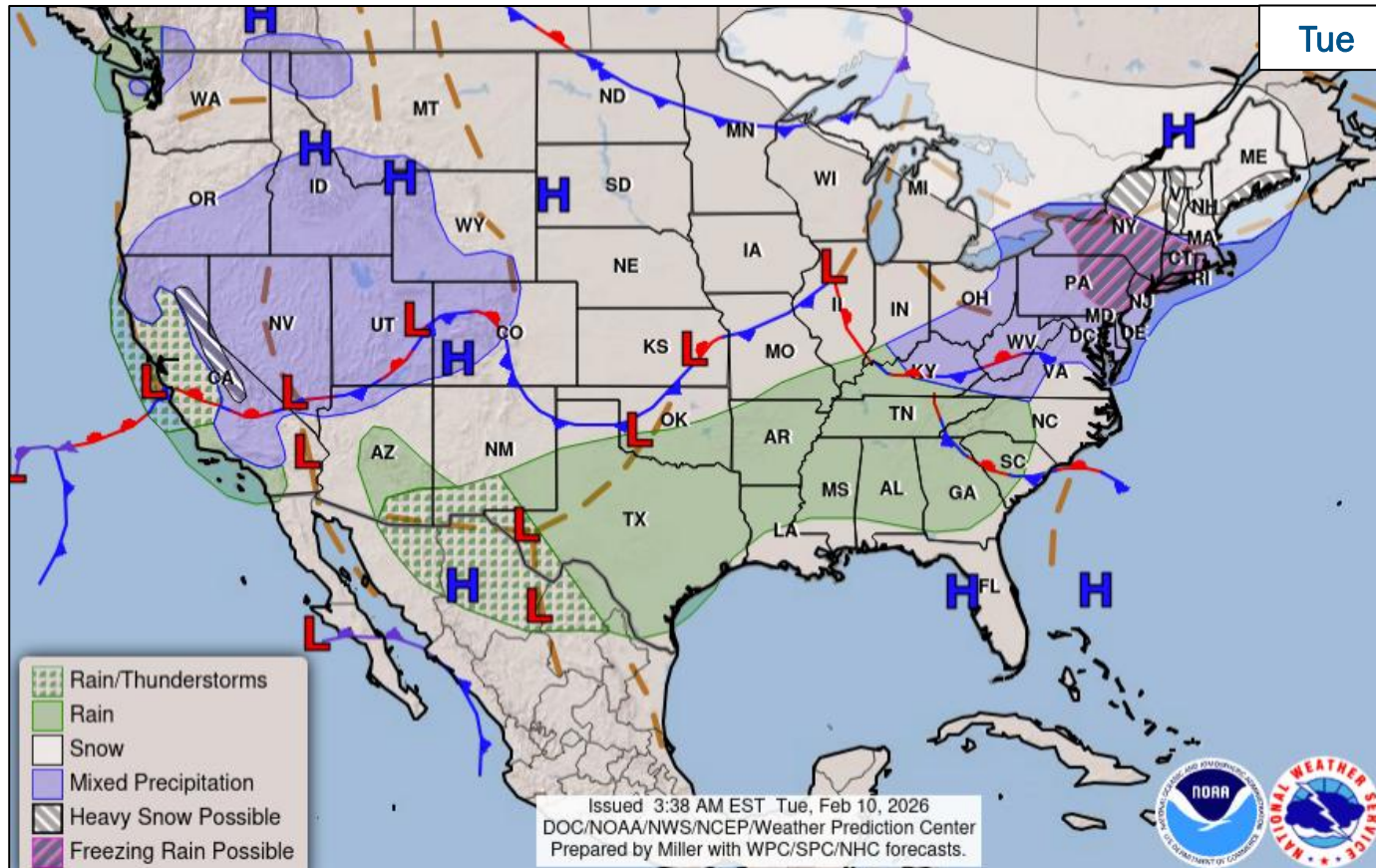

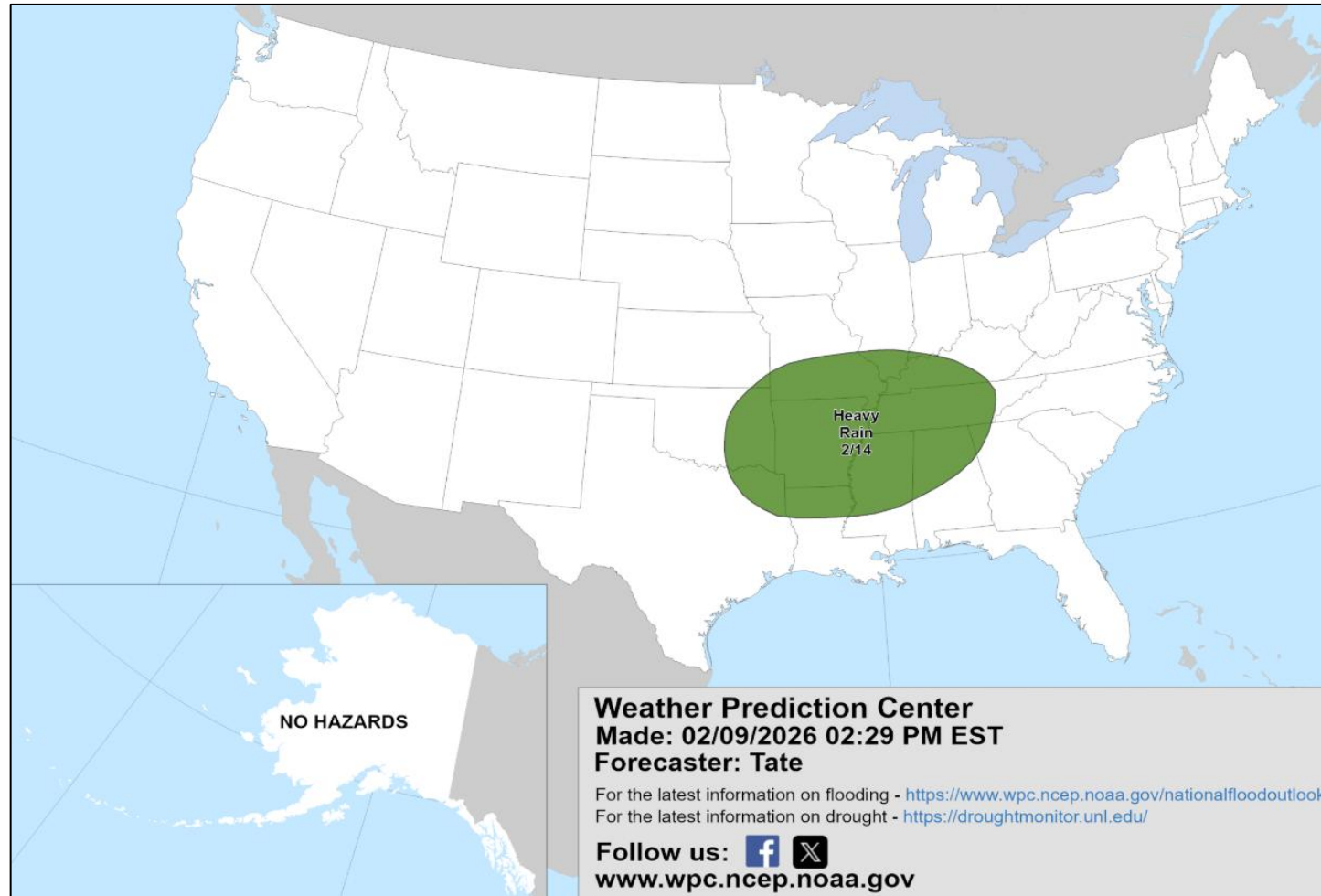
National Weather Forecast

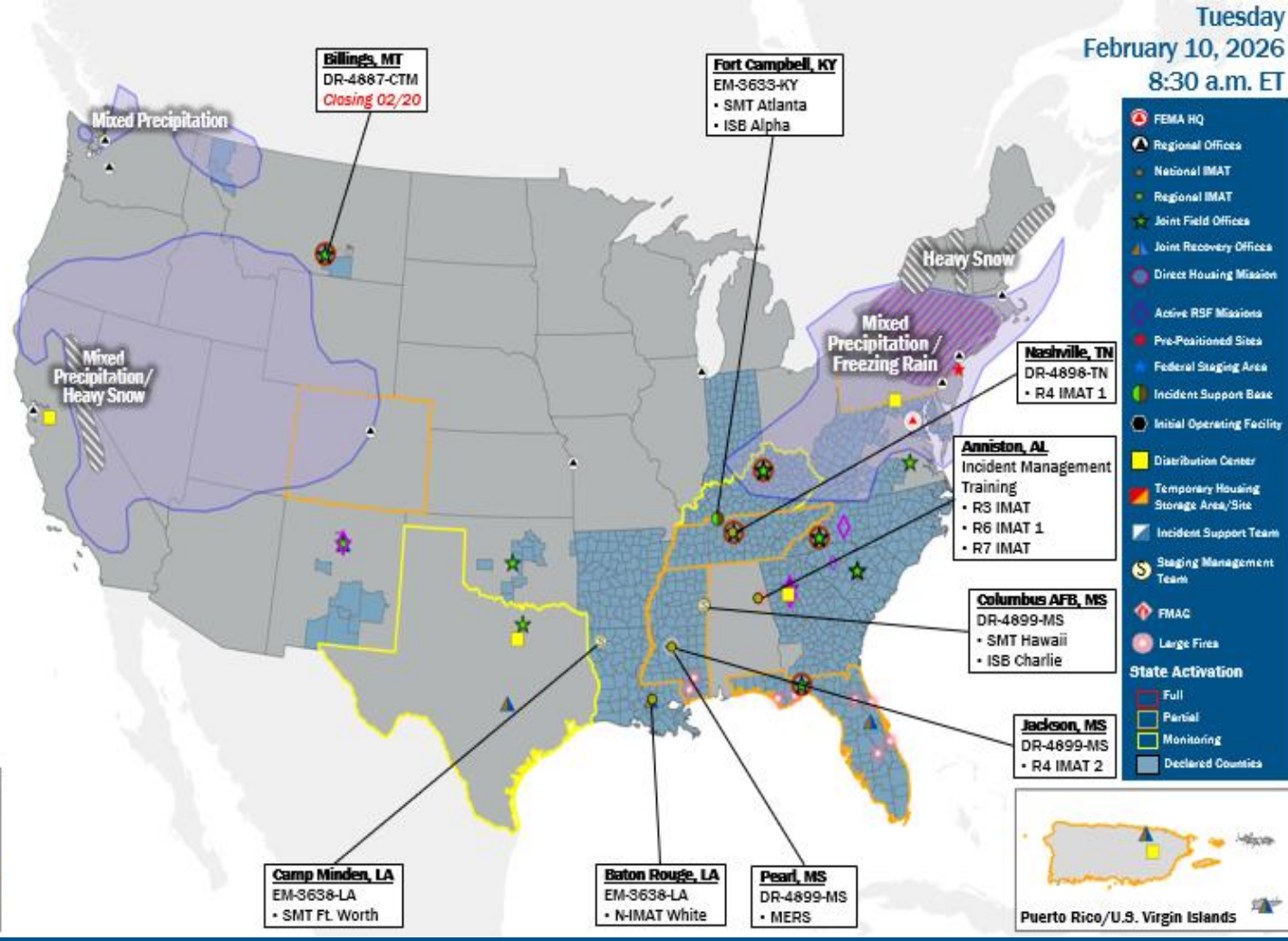
